The joint sickness insurance scheme (JSIS) has established agreements with hospitals and other health providers in order to regulate the maximum fees charged by doctors, surgeons and in some establishments, room prices. See the list by countries below.

Other agreements are established with some centres for the <u>health screening</u> <u>programmes</u>.

They do not modify the procedures to be followed (prior authorisation, letter of direct billing in case of hospitalisation) nor the conditions or rate of reimbursement laid down in the Rules. Therefore they do not always guarantee a reimbursement of 80 or 85%. You have the free choice of hospital or clinic and practitioner.
